May kindly see the property statement online received from Sri Jagannath Mishra, Special Judge (SC/ST, Prevention of Atrocities Act), Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.50,68,775/- (Gross salary is Rs.42,71,282/-, Interim relief arrear of Rs.5,15,577/-, ACP arrear of Rs.62,746/- and amount was paid by DLF as compensatory cost towards construction of Rs.2,19,170/-) and total deductions/repayment/ savings/ investment against GPF, GIS, Income Tax, Home loan, LIC policies and SIPs are Rs.23,70,240/-. Thus, a sum of Rs.26,98,535/- was therefore available with him to meet out the household expenditure of his family consisting six members for both the financial years 2018-19 & 2019-20. And the balance of his savings bank account(s) is also reduced for Rs.1,92,578/- this financial year from previous year's balance.

It is pertinent to mention here that wife of his elder son and younger son are Advocate.

In this connection, it is submitted that officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Manoj Misra, the then Administrative Judge, Maharajganj with the direction issued to "the officer should be cautioned to be careful in future and not to commit such mistake" in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 04.03.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Jagannath Mishra, Special Judge (SC/ST, Prevention of Atrocities Act), Lucknow be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow for His Lordship's kind perusal and orders?
