May kindly see the property statement online received from Sri. Ramesh Chand-I, Presiding Officer, Commercial Court, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20(2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20(2018-19 & 2019-20), Total income is Rs.58,22,943/- (Gross income from salary is Rs.51,40,549/- and Bank Interest is Rs.6,82,394/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, NPS, PPF and LIC Policy's and the balance of his savings bank account(s) is enhanced by Rs.11,76,535/- this financial year from previous year's balance, total of which is Rs.33,13,123/-. Thus, a sum of Rs.25,09,820/- was available with him to meet out the household expenditure of his family consisting of Five members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2016-18 offline and same has been approved by the Hon'ble Mrs. Justice Sunita Agarwal, the then, Administrative Judge, Kanpur Nagar in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 16.03.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-20(2018-19 & 2019-20) of Sri. Ramesh Chand-I, Presiding Officer, Commercial Court, Lucknow be laid before Hon'ble Mr. Justice Vivek Kumar Birla, Administrative Judge, Lucknow for His Lordship's kind perusal and orders?
