May kindly see the property statement submitted online received from Sri Aashish Pandey, Additional Civil Judge, (Sr. Div.)/ACJM, Etawah, regarding submissions of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court. In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income from salary is Rs. 21,90,388/- and total deductions/savings/investments against NPS, GIS, Income tax, PPF and car loan are Rs. 9,46,306/-. Thus a sum of Rs. 12,44,082/- was therefore available with him to meet out the household expenditure of his family consisting of two members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs. 1,30,715/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is working as Senior Research Fellow, B.H.U., having monthly income of Rs. 40,600/-.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2016-18 (2016-17 & 2017-18) which is also processed online and laid before Hon'ble Mr. Justice Raj Beer Singh Administrative Judge, Etawah, for kind perusal and order on e-service Id no 1252.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-19 & 2019-20 vide online dated 08.04.2021. As such, there is some delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2018-20 (2018-19 & 2019-20) of Sri Aashish Pandey, Additional Civil Judge, (Sr. Div.)/ACJM, Etawah, be laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Etawah Judgeship, for his Lordship's kind perusal and order?
