May kindly see the property statements online received from Sri Rishi Kumar, Additional District & Sessions Judge (Fast Track Court), Banda regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-18, Gross salary (including arrears) is Rs.25,57,826/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, loans, Insurance policies, PPF and the balance of his savings bank account(s) is enhanced for Rs.1,14,630/-, total of which is Rs.16,43,345/-. Thus, a sum of Rs.9,14,481/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to be mention here that his wife is Judicial Officer having total annual income of Rs.27,88,290/- for the financial years 2016-18.

In this connection, it is submitted that the officer has already submitted her property statement upto the financial years 2015-16 which had already been seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Bulandshahar in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-17 & 2017-18 vide online dated 01.04.2021. As such, there is delay in submitting the property statement from the part of the officer for which he has submitted that "during the period his wife smt. Nupur was under treatment for Poly Cystic Ovaries Disorder. Later she was diagnosed with Uterine Fibroid and underwent surgery at Sir Gangaram Hospital New Delhi on 26-5-2018 and he had to frequently visit the doctors with her. He was then transfered from Bulandshahar to Banda. Hence he could not submit the property statement in due time.This delay was purely inadvertent and it is humbly prayed that delay may kindly be condoned" mention in remark column.

May, therefore, if approved, property statements for the financial years 2016-17 & 2017-18 of Sri Rishi Kumar, Additional District & Sessions Judge (Fast Track Court), Banda be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Banda Judgeship for His Lordship's kind perusal and orders?
