May kindly see the property statements online received from Sri Rishi Kumar, Additional District & Sessions Judge (Fast Track Court), Banda regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-20, Total income is Rs.36,80,984/- [total Gross salary (including arrears) are Rs.31,03,436/-, Pay commission Interim Relief of Rs.4,21,515/-, arrear of difference of pay after promotion of Rs.41,509/-, salary of E.L. of Rs.64,524/- and LIC money back policy of Rs.50,000/-] and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, loans, Insurance policies and PPF are Rs.21,03,747/-. Thus, a sum of Rs.15,77,237/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.2,84,196/- this financial year from previous year's balance.

It is pertinent to be mention here that his wife is Judicial Officer having total annual income of Rs.46,74,750/- for the financial years 2018-20.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2015-16 which had already been seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Bulandshahar in the misc. file of the officer. And property statements of 2016-18 has been processed on e-service ID no. 2271.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-19 & 2019-20 vide online dated 01.04.2021. As such, there is delay of one day in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Rishi Kumar, Additional District & Sessions Judge (Fast Track Court), Banda be laid before Hon'ble Mr. Justice Rajesh Singh Chuahan, Administrative Judge, Banda Judgeship for His Lordship's kind perusal and orders?
