May kindly see the property statement submitted online dated 14.03.2021 received from Dr. Satyawan Singh, Registrar (J)(Listing), High Court, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Gross income from salary is Rs.51,40,549/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, loans, PPF, LIC policy, Mutual fund, Tier-II PRAN and the balance of his savings bank account(s) is enhanced for Rs.79,579/- this financial year from previous year's balance, total of which is Rs.24,35,946/-. Thus, a sum of Rs.27,04,603/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife earns annual income of Rs.2,72,311/- and Rs.2,81,760/- from agriculture & rental income.

In this connection, it is submitted that the officer has already submitted his property statement up to the financial year 2009-10 which had already been seen by Hon'ble Mr. Justice Ashok Bhushan, the then Administrative Judge, Mau in the misc. file of the officer and of the financial years 2010-11 to 2015-16 has been recently submitted before Hon'ble the Chief Justice for kind perusal and orders with the detailed office note, in the misc. file of the officer. Property statements of the financial years 2016-17 & 2017-18 has been submitted online with detailed office note on e-service Id no. 2305 for kind perusal & orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 up to March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 14.03.2021. As such, there is no delay in submitting the same.

Here, it is also submitted that as per resolution dated 12.07.2013 of Hon'ble the Administrative Committee, the matter is likely to be submitted before Hon'ble the Chief Justice, as the officer is presently posted at High Court, Lucknow Bench, Lucknow.

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 (2018-20) of Dr. Satyawan Singh, Registrar (J)(Listing), High Court, Lucknow Bench, Lucknow be laid before Hon'ble the Chief Justice for His Lordship's kind perusal and orders?
