May kindly see the property statement online received from Sri Ram Narayan, Spl. Judge (E.C. Act), Azamgarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-2020 (2018-2019 & 2019-2020) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-2020 (2018-2019 & 2019-2020) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

(1) In the financial years 2018-2020, total income is Rs. 47,20,242/- (Income from salary - 46,20,242/- and Income from agriculture - 1,00,000/-) and total deduction/ repayment/ savings/ investment/ against G.P.F., G.I.S., Income Tax, L.I.C., repayment of Home loan are Rs. 26,93,029/- (including enhancement of Rs.6,60,547/- in his S.B. A/cs against the balance of the previous year). Thus, a sum of Rs. 20,27,213/- was available with him to meet out the household expenditure of his family consisting six members for the financial year 2018-2020.

In this connection, it is further submitted that officer has already submitted his property statement for the period of 2016-2018 which had already been seen by Hon'ble Mr. Justice Ram Surat Ram (Maurya), the then Administrative Judge, Bulandshahar on the miscellaneous file of the officer.

It is again submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2018-2020 (2018-2019 & 2019-2020) in its next financial year i.e. 2020-2021 upto March, 2021. He has submitted movable and immovable property statements of the financial years 2018-2020 (2018-2019 & 2019-2020) vide online letter dated 12.03.2021. As such, there is no delay in submitting the aforesaid property statements from the part of officer.

May, therefore, if approved, property statements for the financial years 2018-2020 (2018-2019 & 2019-2020) of Sri Ram Narayan, Spl. Judge (E.C. Act), Azamgarh, be laid before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Azamgarh for His Lordship's kind perusal and orders?
