

## **Registrar(J)(Budget)**

May kindly see the reply submitted online received from Sri Ravindra Kumar-II, Presiding Officer, Motor Accident Claims Tribunal, Lucknow, in compliance of order of Hon'ble Mr. Justice Rajnish Kumar, the then Administrative Judge, Hardoi in the matter of property statement, communicated to the officer.

In this connection, it is submitted that earlier the officer had submitted his movable & immovable property statements for the financial years 2018-19 & 2019-20 which were put up before Hon'ble Administrative Judge, Hardoi through detailed online office note dated 29.03.2022 on which His Lordship has been pleased to pass the following online order dated 31.03.2022:

**“ Officer to submit the information in column 4 as the moveable property held by the officer in the financial year is also required to be given.”**

The order of the Court had been communicated to the officer concerned on 31.03.2022.

The officer concerned has replied (in his verbatim) that

**“1-before service, wife got Stridhan in marriage dated 29.4.22 I.e. 35 tola gold**

**2- Son got 10 tola gold and 500 gm silver in different rituals.**

**3- one old car.**

**Above are the only movable properties having more than basic salary.”**

Here, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.89,95,147/- (Gross income from salary is Rs.58,14,772/-, matured amount of FD & LIC are Rs.2,49,464/- & Rs.27,21,433/- respectively and bank interests of Rs.2,09,478/-) and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, LIC, PPF, SIP and the balance of his savings bank account(s) is enhanced for Rs.55,37,340/- this financial year from previous year's balance, total of which is Rs.86,81,243/-. Thus, a sum of Rs.3,13,904/- was therefore available with him to meet out the household expenditure of his family consisting four members in both of the financial years.

It is pertinent to mention here that his wife is posted as Joint Director prosecution, EOW, Kanpur having annual income of Rs.12,22,341/- and Rs.15,60,114/- in the financial years 2018-19 & 2019-20 respectively.

`In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice B. Amit Sthalekar, the then Administrative Judge, Varanasi and statements of 2016-17 & 2017-18 has already been seen by Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Hardoi, placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 25.03.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statement of the financial years 2018-19 & 2019-20 alongwith reply/compliance of Court's Order as desired by the Court in the matter, furnished by Sri Ravindra Kumar-II, Presiding Officer, Motor Accident Claims Tribunal, Lucknow be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow for His Lordship's kind perusal and orders?
