May kindly see the property statement online received from Smt. Kamayani Dubey, Chief Judicial Magistrate, Etah regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2018-20 (2018-19 and 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 and 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial years 2018-20 (2018-19 and 2019-20)**, her gross income from salary is Rs.24,39,962/- and total deductions/Savings/investments against Deposits in Saving Bank Account, NPS, GIS, Income Tax, Repayment of Car Loan, PPF and Insurances are Rs.15,25,537/-. The balance of Rs.97,116/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.9,14,425/- was therefore available for herself to meet out the household expenditure in the financial years 2018-20 (2018-19 and 2019-20).

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2016-18 (2016-17 and 2017-18) online against case id- P00003422021 (old case id-2356), and same has been processed before Hon'ble Mr. Justice Nalin Kumar Srivastava, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders. .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 and 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She had submitted movable and immovable property statements for the financial years 2018-20 (2018-19 and 2019-20) vide online dated 05.04.2021 on eServicesJo portal. As such, there is delay (Only 5 days delay) in submitting the same. In this regard, officer verbatim: "...due to some unavoidable circumstances few documents were not available at the time of filling property statement. This humbly submitted that kindly condone the delay in filing of property statement.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 and 2019-20) of Smt. Kamayani Dubey, Chief Judicial Magistrate, Etah be laid before Hon'ble Mr. Justice Nalin Kumar Srivastava, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders?
