May kindly see the property statement submitted online dated 14.03.2021 received from Dr. Satyawan Singh, Registrar (J)(Listing), High Court, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 & 2017-18, total income is Rs.29,28,105/- (Gross salary is Rs.28,98,105/- & HUF income from agriculture of Rs.30,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, loans, PPF, LIC policy, Mutual fund, Tier-II PRAN and the balance of his savings bank account(s) is enhanced for Rs.65,529/- this financial year from previous year's balance, total of which is Rs.14,80,629/-. Thus, a sum of Rs.14,47,476/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife earns annual income of Rs.3,50,000/- and Rs.2,81,365/- from agriculture & rental income.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2009-10 which had already been seen by Hon'ble Mr. Justice Ashok Bhushan, the then Administrative Judge, Mau in the misc. file of the officer and of the financial years 2010-11 to 2015-16 has been recently submitted before Hon'ble the Chief Justice for kind perusal and orders with the detailed office note, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 up to March 2019. He has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 vide online dated 14.03.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "he have already submitted the property statement of FY-2016-2017 offline alongwith property statement of the FY 2014-2015 and 2015-2016 which was not to be clubbed as per prescribed Proforma. Hence, he is resending the property statement of FY-2016-2017 with FY 2017-2018 as per Proforma and requested to ignore the previous statement of FY-2016-2017 submitted by him. It is also prayed that the statement could not be submitted in time due to omission and same was the result of inadvertence, hence , kindly excuse the delay. He will be careful in future" mentioned in remark column.

Here, it is also submitted that as per resolution dated 12.07.2013 of Hon'ble the Administrative Committee, the matter is likely to be submitted before Hon'ble the Chief Justice, as the officer is presently posted at High Court, Lucknow Bench, Lucknow..

May, therefore, if approved, property statements of the financial years 2016-17 & 2017-18 (2016-18) of Dr. Satyawan Singh, Registrar (J)(Listing), High Court, Lucknow Bench, Lucknow be laid before Hon'ble the Chief Justice for His Lordship's kind perusal and orders?
