May kindly see the property statement submitted online dated 01.11.2019 received from Sri Prabodh Kumar Verma, Addl. In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial year 2018-19, income from salary and other sources is Rs.19,99,310/- (income from salary encluding F.D. interests Rs.19,09,310/- & income from petrol allowance, HRA, reimbursement of electricity bill and news paper is Rs. 90,000/- (as he has above mentioned in the reply of objection) and total deductions/ repayment/ savings/ investment against GIS, Income Tax, NPS, PPF a/c, Mutual funds and the balance of his savings bank account(s) is also enhanced for Rs.12,10,744/-, total of which is Rs.18,49,209/- this financial year from previous year's balance. Thus, a sum of Rs.1,50,101/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year.

It is pertinent to mention here that his father Sri Jai Ram Verma, Retired Government Servant, Monthly Income 60000/-.

In this connection it is submitted that for the preceding year, he has submitted his property statement upto the financial year 2017-18, which has been seen online by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge Rampur on old case-id no 229.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial year 2018-19 firstly vide online dated 01.11.2019. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2018-19 of Sri Prabodh Kumar Verma, Addl. District & Sessions Judge, Saharanpur be laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders?
