

## **Joint Registrar(J)(Budget)**

May kindly see the property statement submitted online dated 25.03.2021 received from Sri Vijendra Tripathi, Registrar (Judicial)(Digitization), Hon'ble High Court of Judicature at Allahabad, Lucknow Bench, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2005-06 & 2006-07 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2005-06 & 2006-07 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2005-06 & 2006-07, Total Gross income is Rs.4,37,508/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, PPF, LIC policies and the balance of his savings bank account(s) is enhanced for Rs.50,310/- this financial year from previous year's balance, total of which is Rs.2,27,492/-. Thus, a sum of Rs.2,10,016/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining into judicial service which had already been seen by Hon'ble Mr. Justice Yatindra Singh, the then Administrative Judge, Lucknow in the misc. file of the officer. And of the financial years 2003-04 & 2004-05, a detailed online note has been submitted before Hon'ble The Acting Chief Justice for kind perusal & orders on e-service ID no.2500.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2005-06 & 2006-07 in its next financial year i.e., 2007-08 up to March 2008. He has submitted movable and immovable property statements of the financial years 2005-06 & 2006-07 vide online dated 25.03.2021. As such, there is **delay in submitting the same from the part of the officer for which he has stated that "Property statements could not be filled timely due to ill health of wife and rush of work. Inconvenience caused is regretted"** mentioned in **remarks column no. 9.**

Here, it is also submitted that as per resolution dated 12.07.2013 of Hon'ble the Administrative Committee, the matter is likely to be submitted before Hon'ble the Chief Justice, as the officer is presently posted at Hon'ble High Court of Judicature at Allahabad, Lucknow Bench, Lucknow.

May, therefore, if approved, property statements of the financial years 2005-06 & 2006-07 (F.Y. 2005-07) of Sri Vijendra Tripathi, Registrar (Judicial)(Digitization), Hon'ble High Court of Judicature at Allahabad, Lucknow Bench, Lucknow be laid before Hon'ble The Acting Chief Justice for His Lordship's kind perusal and orders?
