May kindly see the property statement online received from Sri Harbans Narain, Additional District & Sessions Judge, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), his gross income from salary and other sources is Rs. 47,01,680/- (Rs. 45,60,134/- from salary, RS.4,27,828/-from Interim relief of Pay Commission, Rs. 54,009/- from Arrear of A.C.P., Rs. 1,31,930/- from interest of saving bank accounts interest ) and total deductions/Savings /investments against GPF, GIS, Income Tax, PPF and Insurances is Rs.31,69,480/- (including enhancement of balance of Rs. 21,47,851/- in his saving bank A/c against the balance of the previous year). Thus a sum of Rs. 16,64,130/- was therefore available with him to meet out the household expenditure of his family consisting of five members in the financial years 2018-20 (2018-19 & 2019-20).

It is pertinent mention here that's officer mother( Farmer) having anual income Rs.1,40,000/-

In this connection, it is submitted that the Officer has already submitted his property statement of financial years 2016-18 (2016-17 & 2017-18), which has already been seen by Hon'ble Mr. Justice Manoj Misra, the then Administrative Judge, Meerut, Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 26.03.2021. As such, there is no delay in submission of property statement.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Harbans Narain, Additional District & Sessions Judge, Lucknow be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow for His Lordship's kind perusal and orders?
