May kindly see the property statement submitted online dated 25.03.2021 received from Sri Vijendra Tripathi, Registrar (J)(Digitization), High Court, Lucknow Bench, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2015-16 & 2016-17 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-16 & 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2015-16 & 2016-17, Total Gross income is Rs.30,68,692/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, Income tax, Car loan, PPF, LIC policies, PLI, RD and the balance of his savings bank account(s) is enhanced for Rs.2,71,463/- this financial year from previous year's balance, total of which is Rs.14,51,938/-. Thus, a sum of Rs.16,16,754/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining into judicial service which had already been seen by Hon'ble Mr. Justice Yatindra Singh, the then Administrative Judge, Lucknow in the misc. file of the officer. And of the financial years 2003-04 & 2004-05, 2005-06 & 2006-07, 2007-08 & 2008-09, 2009-10 & 2010-11, 2011-12 & 2012-13 and 2013-14 & 2014-15, detailed online notes has been submitted before Hon'ble the Chief Justice for kind perusal & orders on e-service ID nos. 2500, 2312, 2316, 2318, 2319 and 2324 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2015-16 & 2016-17 in its next financial year i.e., 2017-18 up to March 2018. He has submitted movable and immovable property statements of the financial years 2015-16 & 2016-17 vide online dated 25.03.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "Property statements is being filed delayed due to death of wife and taking care of children and aged parents and rush of work. Inconvenience caused is regretted" mentioned in remark column.

Here, it is also submitted that as per resolution dated 12.07.2013 of Hon'ble the Administrative Committee, the matter is likely to be submitted before Hon'ble the Chief Justice, as the officer is presently posted at High Court, Lucknow Bench, Lucknow..

May, therefore, if approved, property statements of the financial years 2015-16 & 2016-17 (2015-17) of Sri Vijendra Tripathi, Registrar (J)(Digitization), High Court, Lucknow Bench, Lucknow be laid before Hon'ble the Chief Justice for His Lordship's kind perusal and orders?
