May kindly see the property statement online received from Sri Mukesh Kumar Singhal , Presiding Officer, Motor Accident Claims Tribunal, Moradabad, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below :

(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary including interest of FDR and Bonds is Rs. 53,97,577/-)and total deductions/repayment/ savings/ investment against GPF, GIS, Income Tax, Car Advance, PPF , LIC policies & the balance of his savings bank account(s) is also increased by Rs.2,37,547/- in this financial year from previous year's balance, total of which is Rs.36,41,903/-. Thus, a sum of Rs.17,55,674/- was therefore available with him to meet out the household expenditure of his family consisting three members for both the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2016-18 which has already been seen by Hon'ble Mr. Justice B. Amit Sthalekar the then Administrative Judge, Aligarh in the MIsC. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 16.03.2021. As such, there is no delay in submitting the same from the part of the officer
