May kindly see the property statement submitted online received from Sri Ramesh Dubey, presently posted as Additional District & Sessions Judge, Ghaziabad, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income from salary is Rs. 43,32,727/- and total deductions/savings/investments against GIS, GPF, Income Tax, Insurance Policies, repayment of Loans (Car Loan and Home Loan) and Mutual Funds is Rs. 30,30,219/-. Thus a sum of Rs. 13,02,508/- was therefore available with him to meet out the household expenditure of his family consisting of five members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs. 5,39,182/- this financial year from previous year's balance.

It is pertinent to mention here that his father is a retired teacher and his annual income from pension and agriculture is Rs. 3,60,000/- and Rs. 4,00,000/- respectively.

In this connection, it is submitted that the officer has also submitted his property statements online for the financial year 2016-18 (2016-17 & 2017-18) which is already approved online by Hon'ble Mr. Justice Om Prakash VII, the then Administrative Judge, Jaunpur, on e-service Id no. 34.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 16.04.2021. As such, there is some delay in submitting the same from the part of the officer, for which officer has not given any reason.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Ramesh Dubey, presently posted as Additional District & Sessions Judge, Ghaziabad, be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Ghaziabad for his Lordship's kind perusal and orders?
