May kindly see the property statement online received from Smt. Kamayani Dubey, Chief Judicial Magistrate, Etah regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2016-18 (2016-17 and 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 and 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial years 2016-18 (2016-17 and 2017-18)**, her gross income from salary is Rs.9,62,395/- and total deductions/Savings/investments against Deposits in Saving Bank Account, GIS, Income Tax, Repayment of Car Loan & Down payment, NSC, PPF and Insurances are Rs.5,68,750/-. The balance of Rs.90,678/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.3,93,645/- was therefore available for herself to meet out the household expenditure in the financial years 2016-18 (16.01.2017 to 31.03.2017 and 01.04.2017 to 31.03.2018).

In this connection, it is submitted that the Officer has already submitted her property statement Held at the time of Joining in to U.P. Judicial Service online against case id-P00001262021 (old case id-2102), which had already been seen by Hon'ble Mr. Justice Vivek Agarwal, the then Administrative Judge, Raebareli Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2016-18 (2016-17 and 2017-18) in its next financial year i.e., 2018-19 upto March 2019. She had submitted movable and immovable property statements for the financial years 2016-18 (2016-17 and 2017-18) vide online dated 31.03.2021 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer verbatim: "...due to some unavoidable circumstances few documents were not available at the time of filling property statement. This humbly submitted that kindly condone the delay in filing of property statement.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 and 2017-18) of Smt. Kamayani Dubey, Chief Judicial Magistrate, Etah be laid before Hon'ble Mr. Justice Nalin Kumar Srivastava, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders?
