May kindly see the property statement online received from Sri Munna Prasad, Additional Principal Judge, Family Court, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2010-12 (2010-11 & 2011-12) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2010-12 (2010-11 & 2011-12) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2010-12 (2010-11 & 2011-12), his gross income from salary is Rs.15,99,181/- and total deductions/Savings/investments against CPF, GIS, Income Tax, Insurance, Repayment of Car loan and Personal Loan are Rs.5,84,318/-. The balance of Rs.68,039/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.10,14,863 /- was therefore available with him to meet out the household expenditure of his family consisting five members in the financial years 2010-12 (2010-11 & 2011-12).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of Joining in to U.P. Judicial Service along-with for the financial years 2006-08 (2006-07 & 2007-08) and 2008-10 (2008-09 and 2009-10) in offline and same has been processed before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2010-12 (2010-11 & 2011-12) in its next financial year i.e., 2012-13 upto March 2013. He has submitted movable and immovable property statements for the financial years 2010-12 (2010-11 & 2011-12) vide online dated 23.03.2021. As such, there is delay submitting the same. In this regard: officer verbatim: "Due to rush of work I could not submit the property statement within time for which I highly regretted."

May, therefore, if approved, property statements for the financial years 2010-12 (2010-11 & 2011-12) of Sri Munna Prasad, Additional Principal Judge, Family Court, Lucknow be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
