May kindly see the property statement received online from Sri Munna Prasad, Addl. Principal Judge, Family Court, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2012-2014 (2012-13 & 2013-14) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2012-2014 (2012-13 & 2013-14) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2012-2014 (2012-13 & 2013-14), the Gross income is Rs.16,40,051/- (Rs.15,80,551/- from Salary and Rs.59,500/- from maturity of NSC) and total deductions/savings/investment against NPS, GIS, Loan repayments and Income Tax is Rs.8,11,174/-. Thus, a sum of Rs.8,28,877/- was therefore available with him to meet out the household expenditure of his family consisting five members of the financial year 2012-2014 (2012-13 & 2013-14) and the balance of his savings bank account(s) is also decreased by Rs.33,710/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2010-2012 (2010-11 & 2011-12) online against Case Id : P00003542021 (Old Case Id : 2370) and the same has been processed before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2012-2014 (2012-13 & 2013-14) in its next financial year i.e., 2014-15 upto March 2015. He has firstly submitted movable and immovable property statements of the financial year 2012-2014 (2012-13 & 2013-14) vide online dated 24.03.2021. As such, there is delay in submitting the same from the part of officer for which he has stated in his online reply dated 04.09.2024, that "*due to rush of work I Could not submit the Property Statement within time for which I highly regretted.*"

May, therefore, if approved, property statements for the financial year 2012-2014 (2012-13 & 2013-14) of Sri Munna Prasad, Addl. Principal Judge, Family Court, Lucknow, be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
