It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2012-14 (2012-13 & 2013-14) in its next financial year i.e., 2014-15 upto March 2015. He has submitted movable and immovable property statements of the financial year 2012-14 (2012-13 & 2013-14) vide online dated 31.03.2021. As such, there is delay in submitting the same. In this regard, officer has stated that's due to some unavoidable circumstances.
