May kindly see the property statement online received from Sri Pankaj Jaiswal, Additional District & Sessions Judge, Raebareli regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2016-18 (2016-17 & 2017-18), Gross income (Salary is Rs. 30,20,644/- & Maturity of NSC Rs.73,168/-) Rs. 30,93,812 and total deductions/savings/ investment against NPS, GIS, PPF, Downpayment of two wheeler & EMI, Home loan EMI, AC loan EMI, Income Tax, Insurance policy, Mutual fund, NSC and the balance of his savings bank account(s) is also enhanced by Rs.1,42,138/- in this financial year from previous year's balance, total of which is Rs.17,76,342/-. Thus, a sum of Rs.13,17,470/- was therefore available with him to meet out the household expenditure of his family consisting four members in the both of the financial year.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2014-16 (2014-15 & 2015-16) online against case id- P00003812021 and same has been moved before Hon'ble Mr. Justice Samit Gopal, Administrative Judge, Raebareli for His Lordship's kind perusal and orders..

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial year 2016-18 (2016-17 & 2017-18) vide online dated 31.03.2021. As such, there is delay in submitting the same. In this regard, officer has stated that's due to some unavoidable circumstances . Therefore, he apologise with due respect to the Hon'ble Court for aforesaid delay in submission of property statement.
