May kindly see the property statements online received from Sri Vikas Gupta, A.D.J. (POCSO), Etah regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-19 & 2019-20, Total income is Rs. 52,69,819/- [Total income from salary (including arrear of Interim Relief, LLM increments, Leave salary & ACP) of Rs.50,68,019/- and matured amount of LIC policy of Rs.2,01,800/-] and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Insurance policies, PPF, loan, PLI, SIP, FD and the balance of his savings bank account(s) is enhanced for Rs.1,54,731/- this financial year from previous year's balance, total of which is Rs.33,43,832/-. Thus, a sum of Rs.19,25,987/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is also to mention here that his wife is managing a play school and activity centre in Shashtri Nagar, Ghaziabad since the year 2014-15 having annual income of Rs.4,85,228/- and Rs.4,99,900/- in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Kanpur Nagar in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-19 & 2019-20 vide online dated 01.04.2021. As such, there is delay of one day in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Vikas Gupta, A.D.J. (POCSO), Etah, be laid before Hon'ble Mr. Justice Nalin Kumar Srivastava, Administrative Judge, Etah Judgeship for His Lordship's kind perusal and orders?
