

## **Joint Registrar(J)(Budget)**

May kindly see the property statements online received from Sri Rakesh Tripathi, Judge Special Court, Anti Corruption CBI, Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.70,47,491/- (income from salary is Rs.44,52,461/-, maturity of mutual funds of Rs.9,82,036/-, income from house property of Rs.2,22,000/-, amount returned by his real brother of Rs.10,00,000/- and matured amount of RD of Rs.3,90,994/-) and total deductions/ repayment/ savings/ investment against CPF/NPS, GIS, Income Tax, amount given to his real brother, shares, LIC policies, Home loan and the balance of his savings bank account(s) is enhanced for Rs.10,90,475/- this financial year from previous year's balance, total of which is Rs.50,94,141/-. Thus, a sum of Rs.19,53,350/- was therefore available with him to meet out the household expenditure of his family consisting five members for both the financial years 2018-19 & 2019-20.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Mr. Justice Ram Surat Ram Maurya, the then Administrative Judge, Deoria for kind perusal and orders on the detailed office note, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online attachment letter dated 30.03.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Rakesh Tripathi, Judge Special Court, Anti Corruption CBI, Ghaziabad be laid before Hon'ble Mr. Justice Vivek Kumar Birla, Administrative Judge, Ghaziabad Judgeship for His Lordship's kind perusal and orders?
