May kindly see the reply submitted online dated 18.02.2022 received from Smt. Indresh, Additional Chief Judicial Magistrate, Hathras in compliance of order of Hon'ble Mr. Justice Manish Mathur, the then Administrative Judge, Hathras in the matter of submission of property statement, communicated to the officer.

In this connection, it is submitted that earlier the officer had submitted her movable & immovable property statements at the time of joining into U.P. judicial service which were put up before Hon'ble Administrative Judge, Hathras through detailed online office note dated 19.07.2021 on which His Lordship has been pleased to pass the following online order dated 26.01.2022.

“With regard to the statement of movable properties held by the officer at the time of joining, she does not appear to have mentioned the necessary details such as value, source of the amount, date and year of purchase etc. in respect of the items shown at Sl.no. 1 to 13 under column-4. As such, the officer be asked to re-submit the statement with complete details.”

The order of the Court had been communicated to the officer concerned on 04.02.2022.

The officer concerned has replied that (in her verbatim) as under:

"Respected Sir,

It is kindly to submit that necessary details on objection with regards to the statement of moveable property held by me at the time of joining in year 2017 with respect to items shown at Sl. no. 1 to 13 under column 4 are as under-

- Car Hyundai i10 was purchased by me & my husband in 2011 with down payment of ₹2lakh from salaries and on loan of ₹ 2 lakh 50 thousand from SBI Ghaziabad ,held by me before joining in year 2017.
- One TV, fridge, washing machine ,AC, music system, two bed, one sofa, dinning and dressing table and microwave was given to me by my parents in year 2003 at the time of my marriage, held by me before joining in 2017.
- I was posted as radio maintenance officer in years 2009 at a place different from place of posting of my husband ,so I purchased some basic utility items like one TV, fridge, washing machine, bed ,sofa from my previous job salary amount approx. ₹ 80,000 in year 2009, held by me before joining in 2017.
- Item no 12 & 13 were given to me from parental and in laws side at the time of my engagement in 2002, on my marriage in 2003, on birth of my elder son in 2006 and on birth of my younger son in 2016 as ritual, held by me before joining in 2017."

May, therefore, if approved, property statement at the time of joining into U.P. Judicial Service alongwith reply of Court's Order as desired by the Court in the matter, furnished by Smt. Indresh, Additional Chief Judicial Magistrate, Hathras, be laid before Hon'ble Mr. Justice Anish Kumar Gupta, Administrative Judge, Hathras Judgeship for His Lordship's kind perusal and orders?
