May kindly see the property statement online received from Sri Prabha Nath Tripathi, now posted as Spl. J, Spl C.No 4 (Pre.Cor. Act), Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.42,07,440/- (annual income from salary including arrears of interim relief & ACP is Rs.40,49,812/- and income from interest of Rs.1,57,628/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, PPF, LIC policies, NSC, KVP and Mutual Fund are Rs.28,17,721/-. Thus, a sum of Rs.13,89,719/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.1,47,711/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mrs. Justice Sunita Agarwal, the then Administrative Judge, Kanpur Nagar.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-19 & 2019-20 vide online dated 31.03.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Prabha Nath Tripathi, now posted as Spl. J, Spl C.No 4 (Pre.Cor. Act), Lucknow be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
