May kindly see the property statement submitted online received from Sri Vijay Kumar Katiyar presently posted as Dy. Director Inst. of Judicial Training & Research, Lucknow regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2019-21 (2019-20 & 2020-21), his Total income is Rs.34,14,238/- (income from salary is Rs. 33,68,494/- and income from Mutual fund SIP is Rs. 45,744/-) and total deductions/savings/investments against CPF, GIS, Income Tax, PPF, LIC and Car Loan is Rs.11,75,228/-. Thus a sum of Rs.22,39,010/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his S.B. A/Cs is reduced by Rs.23,578/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2017-19 (2017-18 and 2018-19) which has already been seen by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Bareilly Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto 31st March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) firstly vide his application dated 05.04.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Vijay Kumar Katiyar presently posted as Deputy Director Institute of Judicial Training & Research, Lucknow be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
