May kindly see the property statement online received from Sri Mridul Kumar Mishra, Additional District & Sessions Judge, Meerut regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-20 (2018-19 & 2019-20), Total income from salary & other sources is Rs.70,72,740/- (Income from salary is Rs.59,15,563/- & income from bank Interests is Rs.11,57,177/-) and total deductions/repayment/ savings/ investment against GPF, GIS, LIC, share, Income Tax, repayment of vehicle loan and the balance of his savings bank account(s) is enhanced for Rs.26,692/- this financial year from previous year's balance, total of which is Rs.66,17,595/-. Thus, a sum of Rs.4,55,145/- was therefore available with him to meet out the household expenditure of his family consisting of three members for both the financial years 2018-20 (2018-19 & 2019-20).

It is pertinent to mention here that his wife Smt. Monu tripathi is Joint commissioner G.S.T Income-14,20,000/- per annum.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2016-18 which has already been seen by Hon'ble Mr. Justice Bachchoo Lal, the then Administrative Judge, Bhadohi in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 06.04.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, he has stated that he has submitted it in March 2021 for the financial year 2018-19 and 2019-20 and it is forwarded by the Respected district judge on 6th April 2021, for which he is deeply regretted.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Mridul Kumar Mishra, Additional District & Sessions Judge, Meerut be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Meerut for His Lordship's kind perusal and orders?
