May kindly see the property statement online received from Smt. Pragya Singh-I, Additional Principal Judge, Family Court, Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2017-19 (2017-18 and 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 and 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2017-19 (2017-18 and 2018-19), her gross income from salary is Rs.36,51,760/- and total deductions/Savings/investments NPS, GIS, Income Tax, PPF, RD, Sukanya Samriddhi Yojna, Ra-payment of Personal loan and Insurances are Rs.14,22,274/-. The balance of Rs.1,18,797/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.22,29,486/- was therefore available with her to meet out the household expenditure of her family consisting four members in the financial years 2017-19 (2017-18 and 2018-19).

It is to pertinent mention here that officer's husband [Government Service] having annual income was Rs.8,61,466/- for the financial years 2017-18 and Rs.9,41,000/- for the financial 2018-19 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2015-17 (2015-16 and 2016-17) online against case id:P00007502020 (old case id-1586) and same has been processed before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-19 (2017-18 and 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She had firstly submitted movable and immovable property statements for the financial years 2017-19 (2017-18 and 2018-19) vide online dated 06.04.2021 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer's verbatim: "......Excessive workload and due to Maternity Leave and Child Care Leave the property statement could not be submitted within time. Delay is truly regretted" mentioned in the remerk column of movable property statement.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 and 2018-19) of Smt. Pragya Singh-I, Additional Principal Judge, Family Court, Lucknow be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
