

## **Registrar(J)(Budget)**

May kindly see the online reply dated 09.02.2024 received from Sri Rohit Singh, Special Judge (Ayurved Scam Matter), Lucknow in the matter of property statement, communicated to the officer.

In this connection, it is submitted that earlier the officer had submitted his movable & immovable property statements of the financial years 2015-17 which were put up before Hon'ble Administrative Judge, Lucknow through detailed online office note dated 11.12.2023 on which His Lordship has been pleased to pass the following online order dated 23.01.2024:

**“Delayed furnishing of statement pertaining to financial year 2009-2010 and 2014-2015, a warning was issued by the then Administrative Judge to be careful in future submission of statements. Apparently, such warning has been overlooked this time also. Officer is required to explain as to how and why such laxity stands reflected on his part.”**

The order of the Court had been communicated to the officer concerned on 29.01.2024.

The officer concerned has replied that *“With due respect he wants to state that Due to the covid, transfer and lack of technical knowledge he was not able to submit his property statements. with folded hands, he apologised for that and submitting his explanation. Please consider his explanation. He shall be highly obliged. He has also attached his explanation dated 09.02.2024 and stated therein that:*

*“Property statement for the financial years 2009 to 2015 were submitted by him on 23.04.2018 during his posting at Meerut judgeship and he was transferred from Meerut to Kanpur in the month of May,2018. He could not submitted the statements within time due to required papers being misplaced. Online portal has been started from the year,2019. Initially, property statements could not be sent by him through online portal due to lack of proper technical information. Property statements of the financial year 2009 to 2015 were approved by the Hon'ble Administrative Judge in the year 2020-21 with the warning of timely submission in future but due to the Covid pandemic in the year 2020, required proforma was not available to submit the property statements. Property statements for the financial years 2015 to 2021 were submitted by him through online portal in December, 2021. He has submitted the online statements with delay, in compliance with the order of Hon'ble Court but delay has not been made intentionally by him. He has apologized for delay submission of the aforesaid statements due to transfer, lack of technical knowledge, non-availability of desired documents in time, Covid pandemic, etc. He will always be grateful to the Hon'ble Court for all his kindness.”*

It is further submitted that property statement for the financial years 2017-19 and 2019-21 has been approved online by Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow in eService ID 5896 and 5904 respectively with the remark that “but considering the substantial delay in submitting the property statement, the officer is warned to be quite careful in future in submitting such statements strictly within the time frame fixed” in the statement of 2017-19.

May, therefore, if approved, reply/explanation of Hon'ble Court's order in the matter of property statement of the financial years 2015-17, as desired by the Court in the matter, furnished by Sri Rohit Singh, Special Judge (Ayurved Scam Matter), Lucknow be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow for His Lordship's kind perusal and orders?
