May kindly see the property statement submitted online dated 03.08.2021 received from Sri Manoj Kumar Tiwari, Additional District & Sessions Judge, Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2019-21 (2019-20 & 2020-21), Total income is Rs.38,41,340/- (income from salary is Rs.35,39,100/- & redeem amount of mutual fund is Rs.1,76,240/- and withdrawl from PPF a/c is Rs.1,26,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, PPF a/c, loan, Insurance policies, Mutual fund, Sukanya Samriddhi Yojna and the balance of his savings bank account(s) is enhanced for Rs.2,39,804/- in this financial year from previous year's balance, total of which is Rs.16,06,949/-. Thus, a sum of Rs.22,34,391/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his father Sri Ramarcha Tiwari, Retired as Foreman in S.E.C.L. Hasdeo Area, Pension: Rs.18,000/- per month & Agricultural income: Rs.2,00,000/-per annum and his wife Mamta Tiwari, private teaching ,Income Rs. 10,000/- Per Month.

In this connection, it is submitted that the officer has already submitted his property statements upto the financial year 2017-19 which had already been seen by Hon'ble Dr. Justice Kaushal Jayendra Thaker, the then Administrative Judge, Varanasi on old case-id no.1534.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) firstly vide online dated 03.08.2021 . As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial year 2019-21 (2019-20 & 2020-21) of Sri Manoj Kumar Tiwari, Additional District & Sessions Judge, Varanasi be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Varanasi Judgeship for His Lordship's kind perusal and orders?
