May kindly see the online reply dated 08.02.2022 received from Sri Zeeshan Mehdi, the then Addl. Civil Judge (Jr. Div.) Hathras presently posted as Addl. Civil Judge (Junior Div.), Ghazipur, in compliance of order of Hon'ble Mr. Justice Manish Mathur, the then Administrative Judge, Hathras in the matter of property statements held at the time of entering i.e., of joining into U.P. Judicial Service, communicated to the officer.

In this connection, it is submitted that the officer had submitted his movable & immovable property statements held at the time of entering i.e., of joining into U.P. Judicial Service, which was put up before Hon'ble the Administrative Judge, Hathras through detailed office note dated 07.09.2021, on which His Lordship has been pleased to pass the following order dated 26.01.2022:

"With regard to the statement of movable properties held by the officer at the time of joining, the officer be asked to declare:

- 1. the source of the amount invested by him in various products as shown by him under column-6
- 2. He shall also mention premium amount(monthly/annual) along with maturity value with respect to LIC/PLI policies shown under column-6
- 3. Value with regard to P.P.F. A/c uptil 13.12.19 is shown as Rs.83,505 lacs under column-4 while under column-6, the same has been shown as Rs.83,505/-, which needs clarification."

The order of the Court had been communicated to the officer concerned on 04.02.2022.

In reply/compliance of the Hon'ble Court's Order, the officer concerned has stated that "It is most humbly submitted that the property statement has been updated in the light of objection as follows:-

"(1) the source of the amount invested by him in various products as shown by him under column-6"

Source of Amount for all above investments was the salary of the Officer from previous job as Judicial Magistrate Second Class, Gaya (Bihar Judicial Services)

"(2) He shall also mention premium amount(monthly/annual) along with maturity value with respect to LIC/PLI policies shown under column-6"

LIC Policy: 825812879 commencement date 27/07/2018

Premium is Rs. 8762/- per quarter Sum Assured Value : Rs. 1000000/-

PLI policy with India Post: 0000002232509, issued on 01.08.2018

Premium: Rs. 3525/- per month Sum Assured Value: Rs. 1500000/-

"(3) Value with regard to P.P.F. A/c uptil 13.12.19 is shown as Rs.83,505 lacs under column-4 while under column-6, the same has been shown as Rs. 83,505/-"

Applicant regrets the clerical mistake which has happened in the Property statement in column 4 i.e. the Details of Movable Property. The point number 18 reads as "A PPF Account valuing around Rs.83,505 Lacs uptil 13 December, 2019". Here the word "Lacs" have been written due to typographical error which kindly be omitted and it be read as "18. A PPF Account valuing around Rs.83,505 uptil 13 December, 2019."

May therefore, if approved, movable & immovable property statement held at the time of entering i.e., of joining into U.P. Judicial service alongwith the reply/ compliance of Hon'ble Court's order, as desired by the Court in the matter, furnished by Sri Zeeshan Mehdi, Addl. Civil Judge (Junior Div.), Ghazipur, be laid before Hon'ble Mr. Justice Prakash Padia, Administrative Judge, Ghazipur Judgeship for His Lordship's kind perusal and orders.
