May kindly see the property statement submitted online, received from Sri Vinod Singh Rawat, Registrar, Hon'ble Supreme Court, New Delhi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.56,41,778/- [income from salary (for both the financial years) is Rs.55,43,576/- and Bank interests of RS.98,202/-] and total deductions/repayment/ savings/ investment against NPS, GIS, Income Tax, loans and Insurance policies are Rs.24,93,894/-. Thus, a sum of Rs.31,47,884/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2018-19 & 2019-20. And the balance of his savings bank account(s) is also reduced for Rs.2,92,699/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is working as Library Assistant on a contract basis having annual income of Rs.2,10,000/- & Rs.2,20,000/-in the financial years 2018-19 & 2019-20 respectively.

In this connection it is submitted that for the preceding year, he has already submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble the Chief Justice in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-19 & 2019-20 vide online dated 19.04.2021. As such, there is some delay in submitting the same.

Here, it is also submitted that, as the officer is posted on deputation outside the state, his matter is likely to be submitted before Hon'ble The Acting Chief Justice.
