May kindly see the property statement online received from Sri Ram Kishor Shukla, Additional District & Sessions Judge, Allahabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.49,47,891/- (Income from salary is Rs.48,47,149/-, Agricultural income of Rs.70,000/- and Bank interests of Rs.30,742/-) and total deductions/repayment/ savings/ investment against GPF, GIS, TDS, Insurance policies, PPF, PLI, FDR and the balance of his savings bank account(s) is enhanced for Rs.80,102/- this financial year from previous year's balance, total of which is Rs.37,59,711/-. Thus, a sum of Rs.11,88,180/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2018-19 & 2019-20.

It is pertinent to mention here that his elder son is Advocate having annual income of Rs.7,35,050/- and younger son is Civil Engineer having annual income of Rs.4,78,940/-.

In this connection, it is submitted that officer has already submitted his property statement upto the financial year 2013-14 which had already been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Kaushambi in the misc. file of the officer and property statements of the financial years 2014-15 to 2017-18, a detailed office note has been submitted before Hon'ble Mr. Justice Rakesh Srivastava, Administrative Judge, Allahabad for kind perusal & order, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 24.05.2021. As such, there is delay in submitting the same, for which officer has not given the reason of delay.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Ram Kishor Shukla, Additional District & Sessions Judge, Allahabad be laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Allahabad for His Lordship's kind perusal and orders?
