May kindly see the property statement online received from Sri Satyendra Prakash Pandey, Additional Principal Judge, Family Court, Barabanki regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial years 2015-17 (2015-16 & 2016-17)**, his gross income from salary is Rs.20,07,660/- and total deductions/Savings/investments against Deposits in Saving Bank Account, NPS, GIS, Income Tax, Insurance and FD is Rs.10,89,113/-. The balance of Rs.5,21,413/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.9,18,547/- was therefore available with him to meet out the household expenditure of his family consisting five members in the financial years 2015-17 (2015-16 & 2016-17).

It is pertinent to mention here that Officer's wife (Assistant Commissioner Commercial Tax) annual income was Rs.5,04,544/- and Rs.6,38,739/- in the financial years 2015-16 and 2016-17 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2009-11, 2011-13 & 2013-15 offline, which had already been seen by Hon'ble Mr. Justice Manish Mathur, the then, Administrative Judge, Barabanki Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) vide online dated 09.12.2021. As such, there is delay submitting the same. In this regard: officer verbatim: " the undersigned hereby most humbly tenders an unconditional apology for delay in submitting the above mentioned statements in due time and undertakes that such delay will not occur in future."

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Satyendra Prakash Pandey, Additional Principal Judge, Family Court, Barabanki be laid before Hon'ble Mr. Justice Shree Prakash Singh, Administrative Judge, Barabanki Judgeship for His Lordship's kind perusal and orders?
