In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2019-21 (2019-20 & 2020-21), his total income from salary and other sources is Rs.42,66,766/- (Gross salary including allowances is Rs. 39,22,366/-, income from agriculture is Rs. 15,000/-, income from interests of S.B. & STDR is Rs. 2,15,153/-, income from petrol, paper & electricity is Rs. 1,14,247/-) and total deductions/savings/investments against GIS, CPF, Income Tax, PLI, PPF and tution fee is Rs.25,00,801/- (including enhancement of Rs.8,16,096/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs.19,51,200/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements for the financial year 2017-19 which has already been seen online on old case id no.496 before Hon'ble Mr. Justice Om Prakash-VII, Administrative Judge, Jaunpur Judgeship.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto 31st March 2022. He has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) firstly vide his application dated 14.05.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Sri Rajnesh Kumar, Additional District & Sessions Judge, Aligarh, be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
