In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-17 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2016-17 , his gross income from salary is Rs.14,08,541/- and total deductions/Savings/investments against GPF, GIS, Income Tax, LIC, Loan- repayment and PPF is Rs. 9,05,488/- (including enhancement of Rs. 1,46,367/- in his saving bank a/c against the balance of the previous year). Thus a sum of Rs.5,03,053/- was therefore available with him to meet out the household expenditure of his family consisting of six members in the financial year 2016-17.

It is pertinent to mention here that the Officer's son, Sri Rajesh Kumar is a Deputy Jailer whose monthly income is Rs. 46,000/-.

In this connection, it is submitted that for the preceding years, he has submitted his property statements for the calendar years 1999, 2000, 2001, 2002 and 2003 and for the financial years 2004-05 to 2013-14 which have been processed presently offline and an Office note has been submitted before Hon'ble Mr. Justice Devendra Kumar Upadhyaya, Administrative Judge, Balrampur Judgeship for kind perusal and orders on dated 22.11.2019 and he has submitted his movable and immovable property statement for the financial year 2014-15 and 2015-16 in online mode vide application id no. 234 and 270 which have been processed online and separate office notes have been submitted for orders.

The movable and immovable property statement for the financial year 2016-17 has been submitted by the Officer vide his online case id no. 257 dated 05.11.2019 which was due to be submitted upto the end of the financial year 2018-19 as per two year block policy. As such, there is delay in submitting the property statements from the part of the officer and he has apologised for the delay caused.
