May kindly see the online application received from Shri Saksham Dwivedi, Judicial Magistrate, Faizabad regarding submission of statements of movable and immovable properties for the financial years 2018-20 (2018-19 and 2019-20) on proforma to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 and 2019-20) of the officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial years 2018-20 (2018-19 and 2019-20), his total gross income from salary is Rs. 13,22,887/- and total deductions/savings/investments against Income Tax, PPF, Car Loan, NPS, GIS and the balance of his Savings Bank Accounts is reduced by Rs. 263/- this financial year from previous year's balance, total of which is Rs. 2,97,771/-. Thus, a sum of Rs. 10,25,116/- was therefore available with him to meet out the household expenditure in the financial years 2018-20 (2018-19 and 2019-20).

It is pertinent to mention here that Dr. Ramesh Chandra Dwivedi who is the father of the officer is an earning member and Smt. Kanak Dwivedi is the mother of the officer. Dr. Ramesh Chandra Dwivedi (father of the officer) is working as District & Sessions Judge and his salary is Rs. 25 Laksh per annum (approx) as mentioned in the property statement for the financial years 2018-20 submitted by the officer.

In this connection it is submitted that the officer has already submitted his property statements at the time of joining which has been seen by Hon'ble Mr. Justice Rakesh Srivastava, the then Administrative Judge, Faizabad in the Misc. file of the officer.

The movable and immovable property statements for the financial years 2018-20 (2018-19 and 2019-20) have been submitted by the officer vide his online application dated 03.08.2021 which were due to be submitted upto the end of the financial year 2020-21 i.e. on or before 31.03.2021. As such, there is delay in submitting the aforesaid statement on part of the officer for which he has not given any reason.

May, if approved, the statements of movable and immovable property for the financial years 2018-20 (2018-19 and 2019-20) of Shri Saksham Dwivedi, Judicial Magistrate, Faizabad may kindly be placed before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Faizabad Judgeship for His Lordship's kind perusal and orders.
