May kindly see the property statement online received from Sri Akhileswar Prasad Mishra, Additional District & Sessions Judge, Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary (including arrears of interim relief and ACP and fuel reimbursement) Rs. 43,98,099 and total deductions/savings/ investment against GPF, GIS, PPF, Income Tax, Life insurance policies, Mutual funds, Home loan EMI and the balance of his savings bank account(s) is also enhanced by Rs. 44,016/- in this financial year from previous year's balance, total of which is Rs.21,84,400/-. Thus, a sum of Rs.22,13,699/- was therefore available with him to meet out the household expenditure of his family consisting four members in the both of the financial year.

In this connection, it is submitted that the Officer has already submitted his property statement of financial years 2016-18 (2016-17 & 2017-18) which has already been seen by Hon'ble Mr. Justice Ved Prakash Vaish, the then Administrative Judge, Ambedkar Nagar in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 23.03.2021. As such, there is no delay in submission of property statement.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Akhileswar Prasad Mishra, Additional District & Sessions Judge, Kanpur Nagar be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar for His Lordship's kind perusal and orders?
