(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross incom from salary (including arrears of interim relief and ACP and fuel reimbursement) Rs. 43,98,099 and total deductions/savings/ investment against GPF, GIS, PPF, Income Tax, Life insurance policies, Mutual funds, Home loan EMI and the balance of his savings bank account(s) is also enhanced by Rs. 44,016/- in this financial year from previous year's balance, total of which is Rs.21,84,400/-. Thus, a sum of Rs.22,13,699/- was therefore available with him to meet out the household expenditure of his family consisting four members in the both of the financial year.

In this connection, it is submitted that the Officer has already submitted his property statement of financial years 2016-18 (2016-17 & 2017-18) which has already been seen by Hon'ble Mr. Justice Ved Prakash Vaish, the then Administrative Judge, Ambedkar Nagar in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 23.03.2021. As such, there is no delay in submission of property statement.
