

## **Registrar(J)(Budget)**

May kindly see the property statement online received from Sri Rakesh Kumar Singh-I, A.D.J. (POCSO), Farrukhabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-20 (2018-19 & 2019-20), Total income from Salary including arrears is Rs.42,61,787/- and total deductions/repayment/ savings/ investment against GPF, GIS, LIC, PPF, FD, RD, LIC, Mutual Fund Income Tax, repayment of home loan and the balance of his savings bank account(s) is enhanced for Rs.47,212/- this financial year from previous year's balance, total of which is Rs.29,94,160/-. Thus, a sum of Rs.12,67,627/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2018-20 (2018-19 & 2019-20).

It is pertinent to mention here that Smt. Shalini Singh (Wife) Assistant Teacher, Junior High School, Sultanpur, Salary Rs. 62,445/- per month.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2017-18 which has already been seen by Hon'ble Dr. Justice K.J. Thaker, the then Administrative Judge, Etah in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 08.06.2021. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Rakesh Kumar Singh-I, A.D.J. (POCSO), Farrukhabad be laid before Hon'ble Mr. Justice Shekhar Kumar Yadav, Administrative Judge, Farrukhabad for His Lordship's kind perusal and orders?
