May kindly see the property statement online received from Sri Jahendra Pal Singh, Additional District & Sessions Judge (POCSO), Balrampur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Total income from salary is Rs.41,37,866/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, LIC and the balance of his savings bank account(s) is enhanced by Rs.3,56,362/- this financial year from previous year's balance, total of which is Rs.17,13,665/-. Thus, a sum of Rs.24,24,201/- was available with his to meet out the household expenditure of his family consisting of four members in both of the financial years.

It is pertinent to mention here that elder son of the officer Mr. Paras Yadav is a earning member, as additional Civil Judge (Jr. Div.) Farrukhabad.

In this connection, it is submitted that the officer has already submitted his property statements upto the financial year 2016-18 which is already been seen offline by Hon'ble Mr. Justice Anil Kumar, the then Administrative Judge, Mathura for His Lordship's kind perusal and orders in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 19.07.2021. As, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has condoned his sincere apologies and caution will be taken in future regarding delay in submitting the property statement.
