May kindly see the property statement online received from Sri Sheo Chand, Special Judge (SC/ST, Pev.of Atroci Act), Basti regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

In the financial years 2018-19 & 2019-20, Total income is Rs.47,69,131/- (Income from salary including arrear & allowances is Rs.45,72,429/- and bank FDR interests Rs.1,96,702/-) and total deductions/repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, RD, FD, LIC and the balance of his savings bank account(s) is enhanced for Rs.48,866/- this financial year from previous year's balance, total of which is Rs.28,49,727/-. Thus, a sum of Rs.19,19,404/- was therefore available with him to meet out the household expenditure of his family consisting of four members for both the financial years 2018-19 & 2019-20.

It is pertinent to mention here that Smt. Kalpana Yadav (Wife) Government Teacher, Annual Income for 2018-2019 Rs. 6,10,253/- & for 2019-2020 Rs 7,20,000/- respectively.

In this connection, it is submitted that officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Rajan Roy, the then Administrative Judge, Azamgarh in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 14.07.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, he apologizes for delay.
