May kindly see the property statement online received from Sri. Kalparaj Singh, Additional District Judge (FTC), Sultanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2017-19 (2017-18 & 2018-19), Gross income (salary Rs.36,64,760/- & maturity of RD Rs.8,01,274/-) Rs. 44,66,034/- and total deductions/savings/ investment against NPS GIS, Income Tax, LIC policy, PPF, RD, FD, SIP, Insurance and the balance of his savings bank account(s) is also enhanced by Rs.2,87,074/- in this financial year from previous year's balance, total of which is Rs.38,41,125/-. Thus, a sum of Rs.6,24,909/- was therefore available with him to meet out the household expenditure of his family consisting three members in the both of the financial year.

It is pertinent to mention here that Officer's wife (Painting, Yoga & Wellness training) having annual income Rs.1,40,000.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2016-17 offline seen by Hon'ble Mr. Justice Vipin Sinha, the then Administrative Judge, Bareilly in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial year 2017-19 (2017-18 & 2018-19) vide online dated 16.07.2021. As such, there is delay in submitting the same. In this regard, officer has not given any reason.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri. Kalparaj Singh, Additional District Judge (FTC), Sultanpur be laid before Hon'ble Mr. Justice J.J. Munir, Administrative Judge, Sultanpur for His Lordship's kind perusal and orders?
