

## **Joint Registrar(J)(Budget)**

May kindly see the property statement online received from Sri Surendra Pratap Yadav, Judge Small Causes Court, Sitapur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18 & 2018-19, Gross income from salary is Rs.25,45,413/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Insurance policies, SIP, PPF and the balance of his savings bank account(s) is enhanced for Rs.7,48,561/- this financial year from previous year's balance, total of which is Rs.17,96,758/-. Thus, a sum of Rs.7,48,655/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into judicial service which had already been seen by Hon'ble Mr. Justice Sanjay Misra, the then Administrative Judge, Azamgarh in the misc. file of the officer and for the property statements of the financial years 2009-10 & 2010-2011, 2011-12 & 2012-13, 2013-14 & 2014-15 and 2015-16 & 2016-17 detailed online office notes has been submitted on e-service ID nos. 2648, 2670, 2671 and 2672 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 firstly vide online dated 13.07.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "he could not submit it within time due to bona-fide and unavoidable reasons and highly apologize for not submitting the same with due time and humbly request to excuse him for the same, he will be grateful to the Hon'ble Court forever. In future he will submit his property statement on time. He therefore most humbly requested to kindly place the above property statement as described for kind perusal of the Hon'ble Court" in his attached letter dated 08.07.2021.

May, therefore, if approved, property statements of the financial years 2017-18 & 2018-19 of Sri Surendra Pratap Yadav, Judge Small Causes Court, Sitapur be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Sitapur Judgeship for His Lordship's kind perusal and orders?
