In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2019-20 & 2020-21, Gross income from salary is Rs.30,67,038/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Insurance policies, HDFC fund scheme and PPF are Rs.20,00,402/-. Thus, a sum of Rs.10,66,636/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.7,59,304/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into judicial service which had already been seen by Hon'ble Mr. Justice Sanjay Misra, the then Administrative Judge, Azamgarh in the misc. file of the officer and for the property statements of the financial years 2009-10 & 2010-2011, 2011-12 & 2012-13, 2013-14 & 2014-15, 2015-16 & 2016-17 and 2017-18 & 2018-19 detailed online office notes has been submitted on e-service ID nos. 2648, 2670, 2671, 2672 and 2673 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2019-20 & 2020-21 firstly vide online dated 13.07.2021. As such, there is no delay in submitting the same from the part of the officer.
