May kindly see the property statement online received from Sri Ashok Kumar-X, Additional District & Sessions Judge, Mau regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2010-12 (2010-11 & 2011-12) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2010-12 (2010-11 & 2011-12) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial years 2010-12 (2010-11 & 2011-12)**, his gross income from salary is Rs.26,23,098/- and total deductions/Savings/investments against Deposits in Saving Bank Account, GPF, GIS, Income Tax, Insurance, PPF, Repayment of Car loan, Mutual Funds (SIP) and RD are Rs.20,71,886/-. The balance of Rs.4,76,206/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.5,51,212/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2010-12 (2010-11 & 2011-12).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2004-05 to 2009-10 offline, which had already been seen by Hon'ble Mrs. Justice Sangeeta Chandra, the then Administrative Judge, Aligarh Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2010-12 (2010-11 & 2011-12) in its next financial year i.e., 2012-13 upto March 2013. He has submitted movable and immovable property statements for the financial years 2010-12 (2010-11 & 2011-12) vide online dated 20.07.2021. As such, there is delay submitting the same. In this regard: officer verbatim: "..... some of my personal affairs and on account of being busy in treatment of the illness of my daughter who finally expired on 29.09.2015. I would tender surrender my unconditional apology to the Hon'ble Court, and then to submit very respectfully the circumstances, under which the statement pertaining to my properties could not be submitted well within time, specified by the Hon'ble Court, through C.L. No.16/IV-h-16/Admin (A) dated 13th may 2004 (in continuation of Hon'ble Court's Circular letter No.63/IV-h/16/ Admin A Dated 10.12.1998). The inconvenience caused to the Hon'ble Court, in the captioned matter, is extremely regretted and apologized, once again."

May, therefore, if approved, property statements for the financial years 2010-12 (2010-11 & 2011-12) of Sri Ashok Kumar-X, Additional District & Sessions Judge, Mau be laid before Hon'ble Mr. Justice Chandra Kumar Rai, Administrative Judge, Mau Judgeship for His Lordship's kind perusal and orders?
