(1) In the financial year 2019-21 (2019-20 & 2020-21), Gross income (Salary Rs.36,91,779/-, Maturity of RD Rs.6,90,214/-, Maturity of FD Rs.11,11,290 and SIP Rs.4,54,917/- ) Rs. 59,48,200/- and total deductions/savings/ investment against NPS, GIS, Income Tax, PPF, LIC policy, FD, RD, SIP, Home loan downpayment & EMI is Rs.38,05,193 . Thus a sum of Rs. 21,43,007/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2019-21 (2019-20 & 2020-21) and the balance of his savings account is also decreased for Rs.2,52,121 /- this financial year from previous year balance.

It is pertinent to mention here that Officer's wife ( Painting, Yoga & Wellness training ) having annual income Rs.1,15,000/-.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2017-19 (2017-18 & 2018-19) online against case id-P00006122021 and same has been moved before Hon'ble Mr. Justice J. J. Munir, Administrative Judge, Sultanpur for His Lordship's kind perusal and orders..

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-21 (2019-20 & 2020-21) vide online dated 16.07.2021. As such, there is no delay in submitting the property statement.
