May kindly see the online application received from Shri Yogesh Jain, Civil Judge (Junior Division), Hathras regarding submission of statements of movable and immovable properties for the financial years 2018-20 (2018-19 and 2019-20) on proforma to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 and 2019-20) of the officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial years 2018-20 (2018-19 and 2019-20), his total gross income from salary is Rs. 16,89,399/- and total deductions/savings/investments against Income Tax, PPF, Car Loan, NPS, GIS, insurance policy and the balance of his Savings Bank Accounts is enhanced by Rs. 3,07,394/- this financial year from previous year's balance, total of which is Rs. 10,85,230/-. Thus, a sum of Rs. 6,04,169/-was therefore available with him to meet out the household expenditure in the financial years 2018-20 (2018-19 and 2019-20).

It is pertinent to mention here that Shri Rakesh Jain who is the father of the officer is working as Document Writer in Tehsil Hodal District Palwal (Haryana) having annual income of Rs. 4,10,000 (approx.) and Shri Pawan Jain who is the brother of the officer is working as doctor having annual income of Rs. 5,94,000/- from salary as mentioned in the property statement for the financial years 2018-20 submitted by the officer.


In this connection it is submitted that the officer has already submitted his property statement at the time of joining which has been approved by Hon'ble Mr. Justice Anil Kumar, the then Administrative Judge, Hathras in the Misc. file of the officer.

The movable and immovable property statements for the financial years 2018-20 (2018-19 and 2019-20) have been submitted by the officer vide his online application dated 22.07.2021 and again on 17.11.2021 after clearing the objection raised by the office. The movable and immovable property statements for the financial years 2018-20 (2018-19 and 2019-20) were due to be submitted upto the end of the financial year 2020-21 i.e. on or before 31.03.2021. As such, there is delay in submitting the aforesaid statement on part of the officer for which he has submitted that he was not aware of filing the statement from date of joining to March 2020. He filed property statement for 1 April 2019 to 31 March 2021 and now he is filing property statement for 2018-2020 after making objections. He feels sorry for delay in filing property statement and the mistake will not be repeated again in future.

May, if approved, the statements of movable and immovable property for the financial years 2018-20 (2018-19 and 2019-20) of Shri Yogesh Jain, Civil Judge (Junior Division), Hathras may kindly be placed before Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Hathras Judgeship for His Lordship's kind perusal and orders.
