In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2009-11 (2009-10 & 2010-11) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2009-11 (2009-10 & 2010-11), his gross income from salary is Rs.6,72,209/- and total deductions/Savings/investments against CPF, GIS, Income Tax, Repayment of car loan and Insurance is Rs.3,11,290/-. The balance of Rs.53,432/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.3,60,919/- was therefore available with him to meet out the household expenditure of his family consisting two members in the financial years 2009-11 (2009-10 & 2010-11)..

It is pertinent mention here that Officer's father (U.P. Government Servant) annual income was Rs.3,00,000/- for the financial years 2009-11 (2009-10 & 2010-11).

In this connection, it is submitted that the Officer has already submitted his property statement at the time of Joining into U.P. Judicial Service, offline (Misc. file) and same has been processed before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Siddharth Nagar for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2009-11 (2009-10 & 2010-11) in its next financial year i.e., 2011-12 upto March 2012. He has submitted movable and immovable property statements of the financial years 2009-11 (2009-10 & 2010-11) vide online dated 10.12.2021. As such, there is delay in submitting the same. In this regard, officer verbatim: "I tender my unconditional apology for the delay".
