May kindly see the property statement online received from Sri Kamesh Shukla, Additional District Judge (FTC), Siddharth Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2011-13 (2011-12 & 2012-13) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2011-13 (2011-12 & 2012-13) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2011-13 (2011-12 & 2012-13), his gross income from salary and arrears is Rs.12,04,990/- and total deductions/Savings/investments against CPF, GIS, Income Tax, Repayment of car loan and Insurance is Rs.3,46,485/-. The balance of Rs.20,462/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.8,58,505/- was therefore available with him to meet out the household expenditure of his family consisting three members in the financial years 2011-13 (2011-12 & 2012-13)..

It is pertinent mention here that's Officer's father (U.P. Government Servant) annual income was Rs.2,00,000/- for the financial years 2011-12 & 2012-13.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2009-11 online against case id-P00006282021 (old case id-2685) and same has been processed before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Siddharth Nagar for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2011-13 (2011-12 & 2012-13) in its next financial year i.e., 2013-14 upto March 2014. He has submitted movable and immovable property statements of the financial years 2011-13 (2011-12 & 2012-13) vide online dated 10.12.2021. As such, there is delay in submitting the same. In this regard, officer verbatim: **"I tender my unconditional apology for the delay"**.
